Britney Spears has been in the news recently for fighting against her conservatorship. Her conservatorship has been in effect since 2008. It has allowed Britney's father and another coconservator make decisions on her behalf. Additionally, a bank controls all of Britney's assets which means that she cannot freely spend her money without approval. The conservatorship stems

from Britney's 2008 mental health crisis. Since 2008 Britney has released several albums and held a successful residency in Vegas.

On June 23, 2021, Britney spoke out against the conservatorship in a statement to the court. Her statement has since gone viral. Many blogs, and reports have labeled the conservatorship as a Power of Attorney (POA). This is an inaccurate representation of the POA and the power it grants. What is a Section 606.10 Custodian of the Illinois Compiled Statute?



Section 606.10 requires the designation of a custodian solely for the purposes of all State and federal statutes that require a designation or determination of custody or a custodian. For the purpose of where a child will go to school, the court will look to which parent is designated the 606.10 custodian. This designation DOES NOT affect any aspect of parenting time or parental responsibilities, and it cannot be construed in any way to favor one parent over the other. In Illinois, instead of having custody parents have parenting time and responsibilities which are allocated to each parent based on their specific circumstances. The parent designated as the 606.10 custodian DOES NOT have "custody" of the minor child, but instead <u>(Read more)</u>
